- 1. Some of the recent past fatal failures could be a failure of the steel or the steel manufactured product or a defect in the design and construction or resulting from poor maintenance ignoring the safety of the stakeholders at large.
- 2. It's high time that country takes cognizance of the recurrent and repetitive accidents

and fatalities overlooking the PM's call for Zero-Effect-Zero-Defect.

- 3. Transforming Indian economy from US\$3.5-Trillion economy to US\$10-Trillion and further higher cannot be at the cost of such fatalities of citizens.
- 4. Need for Standardization of:

a) Standardization of Material quality

b) Standardization of all load bearing and critical parts In a manufacturing and structural assembly ... like ... Fasteners, Rivets, Springs, Wires, Wire Ropes, Wire Strands, Pulleys, Hooks, Metallic Gaskets, Hinges, Welded Joints, bolted spherical joints etc... alongwith a pre-defined scrapping life-span as a matter of preventive replacement.

c) Standardization of codes and practices for all construction activities.

- d) Pre-defined life-longevity as a part of scrapping policy for all public utility projects
- e) Standardization of Periodic maintenance protocols operating in different set of operating conditions viz. temperature, humidity, load cycles, atmospheric / surrounding conditions viz. Acidic / alkaline etc...
- 5. This Standardization drive is an integrated requirement across all stakeholders with pre-defined ownership starting from Regulator to steelmaker to steel fabricator and contractor to final end-user / custodian of the final assembly / structure.
- 6. This integrated approach across the supply-chain is important since a good steel may not withstand in case the used in structure with sub-standard design, adverse operating conditions and poor maintenance.
- 7. Similarly, timely and pre-defined preventive maintenance has its own necessity viz. a metallic gasket in a boiler or a chemical reactor if not periodically tested, could result in a fatal accident ... alternately ... a failure of a poor weld-joint or fastener could translate into mass tragedy ... alternately ... a failure of a wire rope could result in a collapse of an elevator ... alternately ... a poorly designed and constructed structure with poor foundation without soil testing, wind-force, material quality, etc. could be fatal ... etc... etc...
- 8. Role of the Regulator for ensuring timely and updated BIS Standards meeting World-Class technical compliance is critical.
- 9. Further, legitimizing import of Non-Prime input material is a token of acceptance to legitimately consume the same disregarding the fatal consequences it could cause.
- 10. Not to ignore, the pollution from construction activities, one of the major challenge for the health and safety of the society at large needs to be regulated not by advising preventive measures but as a mandatory measurable requirement.
- 11. India has seen lots and lots of accidents resulting in fatalities of common man resulting from adopting sub-standard materials, design and construction practices.
- 12. There is a need for collective accountability across various stakeholders to avoid compromised approach towards Standardization of Quality.

Prayer:

- 1. 100% Standardization of all input material alongwith steel intensive manufactured goods like Fasteners, Rivets, Springs, Wires, Wire Ropes, Wire Strands, Chain, Pulleys, Hooks, Metallic Gaskets, Hinges, Welded Joints, bolted spherical joints etc.
- Need for legislating pre-defined scrapping life-span of all public utility projects;
- 3. Design codes and construction practices need to be standardized.
- 4. Ban import of non-prime materials;
- 5. Government to run Quality Awareness campaigns for alerting and sensitizing the public at large for mandatory usage of BIS certified materials.
- 6. All stakeholders across the supply-chain to have BIS registration starting from manufacturer to distributor to final retailer.
- 7. Entire regulatory system to be digitalized to avoid any human intervention for ensuring fool-proof compliance of BIS-standardization.
- 9. Construction activity to be brought under the regulatory mechanism with regards to limiting the pollution.
