These emails are tell-tale signs of fraud, yet the gullible can be trapped and used to blackmail by the fraudsters. These types of Gmail accounts are **TOTALLY FAKE**. So, **you are requested to please ignore this type of email from now & ever for your own and company's security.**

You are also requested to please do not share/ surrender any kind of personal information to the fraudsters. However if you are used to getting any such fake emails, calls & messages. Please inform first to the undersign only to take immediate action against such Cyber Crime.

You are once again requested to please use only the company email ID i.e. belong to

bridgeroof.co.in domain for all official communications.

Please refer our earlier communications memo dated: 09/12/2021 wherein we had repeatedly requested to use only Company's email id having co's domain i.e: @bridgeroof.co.in for all official communications.

It has been observed yet few official communication are continuing with third party email like: gmail, yahoo etc. which are bans by Govt. of India. The said announcement was issued on Feb'2018 where in it has been clearly mentioned that Govt. has decided all the Govt. officials must use email services provided by **National Informatics Centre (NIC)** for official communications.

Accordingly, We had migrated our email services to the centralized server of NIC for security reasons & uniform policy enforcement from Aug'2018. Since then we are aware & encouraging to all concern employees to use official email only with co's domain (@bridgeroof.co.in) for security & safety reasons.

You may be aware that new email creation form is available in Employee Information System Portal (EIS). Hence we once again requesting you please use only company's email for all official communications (sent/receive) to avoid any unwanted threats in future failing which it will invite disciplinary action by the company.
